## **April 15-May 22, 2011**

South Shore Art Center invites entries that offer distinctive, imaginative imagery, across all media. This national juried exhibition asks artists to look back into their past life experiences to find 'roots of inspiration' that manifest themselves in current artworks.

**ELIGIBILITY:** open to all artists and all media. No geographical restrictions. Work must have be recent and not previously shown at South Shore Art Center. **All work must be for sale.** 

**SPECIFICATIONS:** Maximum size 60" any direction; two-dimensional work must be suitably framed and firmly wired. No sawtooth hangers, no sandwich frames. Plexiglas glazing only.

#### **ENTRY PROCEDURE AND FEES:**

**Slides:** All slide entries must be high quality 35mm slides, plastic or paper mounts only. Slides must CLEARLY indicate artist's name, title of work, size (H x W), and medium. Indicate TOP of slide with arrow. On upper right corner indicate entry number to correspond with numbers on entry form.

Jpeg Digital Files: Up to five works may be submitted as jpegs. Image files should be 1200 pixels in the largest dimension, 300ppi. CDs & digital files should be clearly labeled/named starting with the artist's name, numbered corresponding to the entry form. (i.e...baker\_1Untitled) Please limit naming convention to no more than 30 characters. Submit files that can be read on both Mac & PC.

**Statement:** Must be in printed form. Please do not send electronic files for CV & Artist Statements.

Fees: \$25 for up to 3 entries, \$35 for 4, \$45 for 5

### **SALES: ALL WORK MUST BE FOR SALE.**

South Shore Art Center receives 40% of the puchase price. No accepted entry may be withdrawn prior to the close of the exhibition. No pricing changes will be allowed after acceptance.

**LIABILITY:** South Shore Art Center will insure work accepted to the extent of 60% of the artist's stated value while the work is in the Art Center's custody and control.

**AGREEMENT:** Submission to *Sources • Origins* constitutes an agreement with all conditions of this show. South Shore Art Center reserves the right to photograph an accepted work for publicity purposes. South Shore Art Center reserves the right to reject any work not resembling the submitted entry or work that is not ready to be shown according to the aforementioned specifications.

**DELIVERY AND RETURN OF ACCEPTED WORK:** Work may be hand delivered or shipped. For a handling fee of \$25, **South Shore Art Center** will receive and return work to participating artists. Instructions will be sent to those artists whose work is accepted.

#### **ENTRY CHECKLIST:**

- Entries labeled clearly
- Digital files named with artist's last name, number that corresponds with entry form & short title on CD
- Completed entry form
- Artist Statement
- Check or money order or "International Postal Order" if outside of USA

#### **NOTIFICATION:**

Accepted entries will be posted on SSAC website. Shipping instructions will be sent by email.
